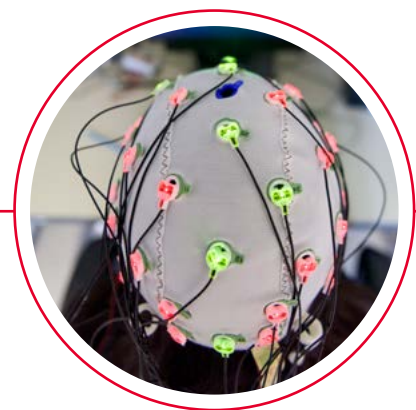

MESSAGE FROM ASSOCIATE DEAN FOR RESEARCH

It is my honor as Associate Dean for Research at Texas A&M University College of Nursing to highlight the growth and expansion of the Texas A&M College of Nursing's research and scholarly activities during calendar year 2020. This past year was an extremely challenging and momentous year for the college, and the nursing profession as a whole. The World Health Organization recognized 2020 as the International Year of the Nurse and Midwife, an honor coinciding with the 200th anniversary of the birth of Florence Nightingale and, ultimately, a year unlike any other. January 2020 began as most other years with the pursuit of key strategic goals and objectives; however, by March 2020, the World Health Organization declared the COVID-19 epidemic a world-wide pandemic, fundamentally transforming every aspect of life. It was during these dark months that health professionals across the world were called upon at levels not seen in more than 100 years since the pandemic of 1918. During 2020, the College of Nursing rose to the challenge with strength, fortitude, creativity and tireless efforts to ensure the safety of students, faculty and staff, continuity of operations including early graduation of nursing students to meet the workforce shortage, and relentless pursuit of research initiatives designed to respond to the needs of the most underserved. The triumphs of the year are the result of the tireless commitment to service as evidenced by The Texas A&M University System and Texas A&M College of Nursing faculty, staff and students.

This report is designed to highlight the many scholarship accomplishments of the College of Nursing which is remarkable given the widespread impacts of the pandemic extended to every area of operations, including research and scholarship. Research operations, scholarship, engagement with participants, clinical sites and communities were reimagined in a pandemic and socially-distanced environment. Faculty and staff not only met these challenges, but they also accelerated the pace of research and scholarship.

During 2020, the College of Nursing research enterprise expanded exponentially. The college received many new competitive awards and research expenditures, totaling more than \$2 million, a milestone considered as an important benchmark by university and system research leadership. More than 40 proposals were submitted requesting more than \$25 million in new funding. Faculty increased research scholarship with 40 articles, more than 60 presentations and 26 posters. Despite travel restrictions and curtailing of in-person activities, the dissemination efforts through virtual conferences and professional meetings increased significantly. The college also received a number of prestigious honors during the year that establish the college as an emerging leader in research focused on the care of the rural and underserved. Among these include a visit by Thomas J.

Engels, United States Health Resources and Services Administration (HRSA) Deputy Director, to the college in September 2020 to announce the launch of the HRSA Rural Communities Opioid Response Program (RCORP) Neonatal Abstinence Syndrome (NAS) award.

At Texas A&M University College of Nursing, we continually strive to highlight and recognize outstanding accomplishments in research and scholarship. There are too many accolades and awards received by faculty to list; however, this report provides a broad overview of the significant research and scholarship accomplishments of the College of Nursing.
